St. Francis Manor is **not** a skilled care facility or an assisted living facility. We are an independent living facility that has been in existence for over 40 years. All of our residents are ambulatory and able to care for themselves. Some residents have made St. Francis Manor their home for over 25 years!

Monthly rent is \$360 for the small unit and \$385 for the large unit (\$410 for lakefront units) (plus \$10 for parking). Rent includes water, trash and sewer services. Residents are responsible for their electricity, telephone and cable. Each unit includes a refrigerator, stove, microwave and air conditioner.

We have over five acres of beautiful park like grounds with abundant shade trees, privacy and safety. Access is all on one level with no steps in the entire 98 apartment complex. St. Francis Manor is a host site for the Senior Resource Association's congregate lunch program, Monday through Friday. Our Manor bus provides transportation for weekly grocery shopping, monthly dining out and other field trips AND the community bus stop is only a block away!
